

#### RIGHT TO DEDUCT WORKSHOP

The first of the series of the 'learn-while-you-smoke' workshops will deal with the Right to Deduct.

The Right to Deduct is the single most important aspect of the VAT legislation. The deduction system is meant to relieve the trader entirely of the burden of the VAT payable or paid in the course of all his economic activities, provided that such activities are themselves, in principle, subject to VAT. The European Court of Justice (ECJ) has ruled time and time again that the right to deduct is a fundamental right of the taxable person and cannot be limited. However the increased complexities of the number and types of transactions that businesses undertake today can lead to errors in input VAT deductions, and disagreements with the VAT authorities, which can consequently become very expensive for the taxable person. Having a solid understanding of the deduction system is therefore paramount. This workshop provides exactly this understanding and covers actual deduction cases by the participants.

The workshop is open to any professional with exposure to VAT matters such as accountants, chief accountants, CFOs, financial controllers, tax advisors, et al. Non-smokers are welcomed if cigar smoke is not an issue for them.

In 2018 Alexis teamed up with jeweller, Raffi der Garabedian and represented Cyprus at the 1st Habanos World Challenge competition held in Cuba, where the Cyprus team won!

For Alexis, there is no perfect moment to appreciate a cigar. "It is not about the birth of the child, the big birthday the promotion or the marriage, although these are all great reasons to light up. It can be as simple as closing one's eyes while drawing the first smoke, allowing the flavors to whisk the mind away to other places, to other times, or to complete nothingness, so that the eyes can reopen with absolute contentment."
